Concentrated pomegranate juice is the unfermented product which can be fermented after reconstitution, preserved exclusively by physical methods but not radiation and obtained by a mechanical & Enzyme process and filtrated or otherwise prepared to exclude skins, fibers and white separation layers between seeds.

PACKAGING:

1- Aseptic

In aluminum pre-sterilized aseptic bag inside a Conical Steel drums clean with total Absence of metal bond and free from corrosion, rusting and flaking Paint, and there is a protective P.E liner between drum and aseptic bag, steel cover is securely sealed on the drums.

2- Frozen

In polyethylene bags or aluminum pre-sterilized aseptic bag inside a Conical Steel drums clean with total Absence of metal bond and free from corrosion, rusting and flaking Paint and there is a protective double P.E liner between drum and aseptic bag, steel cover is securely sealed on the drums.

WEIGHT:

- Net Weight is 250 ± 2 kg per Drum

LABELLING :

Each drum is to be clearly marked in Arabic, English in non-erasable ink with the following :

- Manufacturer Name and Address
- Drum Progressive Number
- Date of Filling
- Expiration Date
- Net Weight
- Pulp Concentration
- Product Type
- Filling Head Number
- Patch number

STORAGE / SHELF LIFE:

24 months starting from the production date, Drums shall be stored in covered, cool and dry environment, protected from sand, dust and direct sunshine .

Storage temperature should be the ambient temperature (not more than + 25 °) for Aseptic Packaging, for Frozen Packaging Drums must be stored in at least -18° C

PRODUCTION MANAGEMENT UNDER :
